Mera was a 228-ton single-cylinder cargo ship built by William Allsup & Son's, Preston for J. Sinclair. She was wrecked off the Minquiers Rock, Channel Islands on the 19th February 1887 in water ballast between Granville and Cardiff. The Master, Mate, two engineers and a crew of eight were saved, landing in Southampton on the 24th of February.

George Milne's Inver Line commissioned a splendid fleet of fourteen very similar steel barques between 1889 and 1902, *Inverlochy* being one of three identical sisters built by Russell & Co. of Port Glasgow in 1895. Each was registered at 1,472 tons gross (1,339 net) and measured 238 feet in length with a 36 foot beam. Despite the strength of her steel hull, *Inverlochy's* career was a short one when she was wrecked on the Ingoldsby Reefs, off Split Point, Victoria (Australia) whilst inbound for Melbourne from Liverpool in December 1902 due to a serious navigational error by her master.





Built by R. Steele & Co of Greenock for the Allan Line, *Ravenscrag* (named after the eponymous Scottish castle) registered 1,253 tons, was 219ft long with a breadth of 35ft. She plied a steady and successful trade to the United States and is even credited with introducing the ukulele to Hawaii when she carried 400 Portuguese immigrant labourers from Madeira in 1879. The Allan Line sold her in 1885 to J.C. Richardson of Swansea who ran her for eleven years and so it is their House flag depicted in this fine painting. Bought by F.G. Mabane of South Shields in 1896, they sold her again in 1901 to the Norwegian company J. Johanson & Co of Oslo who renamed her *Armenia* and re-rigged her as a barque. She was wrecked in 1907 attempting to put into Port Matane (Quebec) in thick fog.



moored at Blackwall, then Gravesend, Portsmouth and thence to Bengal, 25 April 1803-7 February 1804 with a month stop at Rio de Janeiro (18 September-16 October) for repairs and supplies, 110 pp. Most of the entries are standard for this type of log: weather, cleaning the ship, washing clothes, making gaskets and sails, the log finishes abruptly on Thursday 7 February 1804 with *Earl Spencer* still at sea, numerous blank pages at the end, contemporary reverse calf (*slight damage to spine*), folio — 14¾ x 9in. (37.5 x 23 cm.)

Earl Spencer was a 644-ton ship built in Perry's Yard, Blackwall for James Duncan, and launched in 1795. Plying a steady trade to the Coromandel Coast and Bengal, in 1811 she was chartered by the British government and used to transport convicts to Botany Bay, her final fate is unrecorded.

Charles Augustus Ranlett (1804-1878) and his son and namesake, Charles Augustus Ranlett Jr. (1836-1874) hailed from a Charlestown (Massachusetts) maritime family. Both father and son would in time captain the American clipper ship, Surprise. An early clipper ship, Surprise was built in 1850 to the order of A A Low & Brother. She was built by Samuel Hall of East Boston, with Samuel Hartt Pook as a designer. Although her first voyage was from New York to San Francisco, she spent the majority of her long working life plying the China trade. She set several speed records and was one of the most profitable clipper ships ever built. On one notable voyage she carried the Roosevelt family to Shanghai, a journey described in the biography of the mother of American President Franklin Delano Roosevelt, Sara Delano Roosevelt, Gracious Lady. She was still trading to the Far East when lost in February 1876 near Yokohama. The Ranlett Family Papers (1791-1948), Series I and II, are housed in the Phillips Library, Peabody and Essex Museum, Salem, Massachusetts.



Carmania, 19,650 tons, was built in 1905 for Cunard's Liverpool to New York supplementary service and during the winter months either relieved the regular mail steamers or sailed from Fiume on the American tourist route to and from the Mediterranean. On the morning of 14 September 1914, off the western end of the island of Trinidad, the 18,700 ton German Armed Merchant Cruiser Cap Trafalgar, was surprised in the act of coaling by the Carmania, under the command of Captain Grant, R.N. At first she made off at high speed, but later turned about and prepared to engage. Both ships began firing at 7,500 yards, the 4.7-in guns of the Carmania doing great damage to the hull of her enemy. The fire from the Cap Trafalgar was initially too high, but as the ships closed she began to score, setting Carmania on fire under the forebridge and cutting her main water pipe so that the fire could not be brought under control. After an engagement lasting one hour and forty minutes, the Cap Trafalgar was ablaze and sinking. Towards the end of the action, she attempted to escape, but her engines were not equal to the strain and she finally capsized to port and sank by the head. Five boats crowded with survivors were picked up by the German colliers, the Carmania being still on fire and too badly mauled to render assistance. Carmania herself survived and was, in fact, the only Armed Merchant Cruiser ever to have sunk a similar antagonist in a straight gun duel; when, after extensive repairs, she returned to sea, she found herself with an unrivalled reputation that outlived her long after she was broken up in 1932.



Robert Charles Malden (1797-1855) proceeded in the *Scipion* to the Bay of Biscay and in the *Nisus* to the East Indies and assisted at the reduction of Mauritius and Java. Soon after the commencement of the war with America, he was sent home in a captured American Indiaman. Returning to the expedition against New Orleans where he suffered badly from frostbite. In the summer of 1824 he accompanied Lord Byron in the *Blonde* for a surveying expedition to the Pacific during which voyage they escorted the remains of the late King and Queen of the Sandwich Islands, and Byron honoured Malden by naming an island after him, returning in the spring of 1826 when he was discharged. The bark paper included with the descriptive voyage in lot 112 was collected by Malden on this trip.

This bronze is a duplicate of the example held by the National Museum of the Royal Navy, Portsmouth (Item No. 1973/144) which, until this model surfaced recently, was thought to be the only example cast by Queen Victoria's talented youngest daughter. In fact, the firm that supplied the raw materials to her chosen founders, Henry Young & Co., persuaded them to run off a secret second copy before they destroyed the mould. This version was kept, with some trepidation, by the family, until recently re-discovered in an attic where it seems to have languished for most of its existence. Henry Young & Co. also executed work for Alfred Stevens and Joseph Edgar Boehm.

The sculptress, **Princess Louise**, **Duchess of Argyll (1848-1939)**, the sixth child of Victoria & Albert was an artistically gifted young lady and worked in watercolour, marble and bronze. An extensive group of watercolours is located at Windsor Castle, and her full-sized statue of her mother, Queen Victoria, still stands outside Kensington Palace. The date on this bronze suggests she was somewhat 'caught out' by the national furore that surrounded the centenary of Trafalgar, but the result does not disappoint and she has given Nelson a less formidable air than he has in other examples, depicted hatless but otherwise in full dress with orders and decorations, and carrying a telescope giving him a humane but busy appearance, one which resonates with contemporary accounts.







THOMAS DITCHBURN (1801-1870)

Thomas Ditchburn was a British engineer and shipwright. In 1837 he founded the Ditchburn and Mare Shipbuilding Company with Charles Mare. This went on to become the Thames Ironworks and Shipbuilding Company based in Blackwall. His close relationship with Lord Alfred Paget, Equerry to Queen Victoria, probably led to the commission of the royal yacht, Fairy, (see lots 166 and 167) but before that, he had designed and built for Paget the winning iron cutter, Mystery, as well as the Volna for the Grand Duke Constantine and the world's first all iron battleship Warrior.

Chapman's splendid publication revolutionized the study of Naval Architecture when it was first published in 1768. It went on to several reprints. Together with its companion volume, the *Tractat om Skepps-Byggeriet* it had a profound influence on the design of warships in the eighteenth century. During the period of the Russian Wars of 1788-90 it became clear to Chapman that bigger warships were capable of fighting in the shallow Baltic waters and he prepared a series of design proposals for the Swedish Admiralty for vessels of up to 110 guns. Although approved, only their models were ever built, which survive and can be seen in the Swedish Maritime Museum, Stockholm.



H.M.Y. Fairy was designed and built by T.J. Ditchburn of Blackwall in 1845. She acted as first lender to *Victoria & Albert I* and accompanied her on many voyages. Her first duty was to attend the Royal Yacht in Antwerp to take Queen Victoria and Prince Albert on board for a cruise in the shallow waters of the Scheldt. She was sailed many times in Scotland and conveyed members of the Royal Family to and from Osborne House. *Fairy* was replaced by the more robust *Alberta* in 1863 and broken up in 1868. The high quality nature of these drawings would indicate a London draughtsman and it is known that both Thomas Dowbiggin and Holland & Sons supplied Osborne House around this date. The builder's model of *Fairy* by Ditchburn is now in the National Maritime Museum, Greenwich (inv. no SLR0208).

The Nares expedition was commissioned by the Admiralty as a voyage of scientific discovery, the main aim being the conquest of the North Pole, H.M. Ships *Alert* and *Discovery* setting sail from Portsmouth on May 29th 1875. The expedition achieved a 'farthest north' record, but failed to reach the Pole, nevertheless, significant scientific data was gathered and a considerable portion of the north Greenland coast mapped. It was also significant for including photographers and George White, Assistant Engineer for *Alert* and Thomas Mitchell, Paymaster for *Discovery* were trained at the Army School of Photography in Chatham expressly for the purpose. Between them they took some of the earliest images of polar exploration and set a precedent in the field of photography followed by later professionals such as Herbert Ponting and Frank Hurley.

Launched by Barrow SB in 1877 as the 226-ton schooner-rigged yacht *Cruiser* for the Earl of Eglinton, he sold her in 1881 to the Governor of Fiji who added engines and lengthened her, increasing her displacement to 353 tons. In 1882 she was sold to the Royal Navy and renamed *Dart*. Originally intended to as the official yacht for the Admiral in charge of the Australia Station, instead, she was fitted out as a survey ship working with several other smaller craft to survey large areas of the Australia Station including the Pacific Islands and New Zealand. In 1904 *Dart* was loaned to the NSW government for use as a seagoing tender for the government's boys school ship *Sobraon* and, when that ship was absorbed into the nascent Royal Australian Navy, *Dart* was also sold on as a training ship. In 1921 she seems to have been sold to French owners based in Noumea (New Caledonia) and was deleted from the list in 1937.

Built by Napier, Glasgow, *Phaeton* was a 4,300 ton Second Class protected cruiser of the Leander Class. Commissioned at Chatham, she served on the Malta and Pacific Stations before being decommissioned in 1903 and serving as a training ship initially for stokers and seamen, and then from 1913 as the *Indefatigable* for a naval charity. She was however re-purchased by the Royal Navy in 1941 and used as an accommodation ship for the duration of hostilities. She was finally sold and sent for breaking at Wards in 1947. Earlier in her career she formed part of Vice-Admiral Sir George Tryon's squadron and witnessed his flagship *Victoria* being rammed and sunk by *Camperdown* during maneuvers off Tripoli in 1893.

The nameship of her Class, *Canopus* was a pre-dreadnought battleship of some 14,300 tons built by Portsmouth DY. The first battleship to be fitted with watertube boilers, she was also fitted with huge 12in. guns. Although obsolete by the Great War, she was sent on patrol and was supposed to join Admiral Craddock's ill-fated squadron but didn't arrive before it was sunk by von Spee. Re-assigned to the avenging squadron of Sir Doveton Sturdee, he grounded her as a harbour defence at Port Stanley where, in anticipation of a competitive gunnery drill, she secretly loaded her 12in. guns. When von Spee surprised the British Squadron in the midst of coaling, she opened fire, scored the first hit and made the Germans turn and flee pursued by the British who sank them in the Battle of the Falkland Islands. *Canopus* went on to serve at Gallipoli, but her age was evident and she was removed from active service in 1916 and broken in 1920.

This picture forms part of Norman Wilkinson's War at Sea series and is believed the last one in private hands. As a Royal Navy volunteer in World War One, Wilkinson had become all too aware of the threat from Germany's U-boats and decided he could use his artistic skills to protect Allied ships. Realising that it was impossible to paint a ship in a conventional camouflage instead, he proposed that the "extreme opposite" was the answer: Rather than trying to make a ship vanish, he developed a radical camouflage scheme that used bold shapes and violent contrasts of colour, the purpose being to confuse rather than conceal. After trials, the Admiralty agreed and Wilkinson was set up in Burlington House as head of the dazzle section with a team of artists producing designs on model hulls. All classes and types were catered for and amongst the largest projects was Titanic's sister ship Olympic (see previous lot) for which he had also produced stateroom designs before the War.

The Renown is next found in Canada and visiting several Caribbean islands before mooring in Rio de Janeiro (where the ship's officers lost at crickets and football against the local teams). The next port of call for the Renown was New York where two plays and musicals (especially "Hullo Alexander") were greatly appreciated. The Caribbean islands were again visited before a trip through the Panama Canal. New Zealand and Australia were minutely described and there seems to have been a dance every night (most of which were attended by the Prince of Wales). 



THE MICROSCOPE COLLECTION OF THE LATE DR. PATRICK MILL (1933-2023)

Born near London, Patrick's father was the General Manager of a plastics factory, an emerging technology at the time. He was old enough to serve as a volunteer ARP warden towards the end of World War II, staying up all night on fire watch, and helping out in the factory by day. A bright student, he was educated at the local grammar school and passed for Cambridge where he attended Christ's College and after that, he achieved a PhD in biochemistry from UCL. He joined the Lister Institute for Preventative Medicine in Chelsea where he worked on Smallpox vaccines. In the 1950's he left London for Rome to join the International Research Centre for Chemical Microbiology where its Director, Professor (later Sir) Earnest Chain, became a good friend. It was in Rome that Patrick met his wife Jeanette who was working for the UN's Food & Agriculture Organization, marrying in December 1960 they returned to the UK the next year where Patrick continued his research, initially for Guinness the brewers where he published a paper on the action of yeast. He then turned his hand to business management and for the remainder of his career worked for Bayer Diagnostics where he retired as head of business. During his scientific career, he produced some twenty-two papers and several patents. His retirement allowed him to indulge his passion for historical microscopes which stemmed from a 1910 Reichert given to him by his father - an expensive gift at £35 in 1949. He followed the auction sales assiduously and made a private database of all the microscope prices achieved in the London Rooms from the 1970s until shortly before his death. In 1997 he joined the Scientific Instrument Society and by 2003 was on its committee where he served until 2012 - the last four as Chairman. The collection offered here is complete except for a small number kept by the family for sentimental reasons and represents a broad spectrum of microscope development. In many instances, Patrick wrote extensive notes encompassing research and thoughts, which are published online.



- (b) All oral and/or written information provided to Bidders relating to lots, including descriptions in the catalogue, condition reports or elsewhere are statements of CM's opinion and not representations of fact. Estimates may not be relied on as a prediction of the selling price or value of the lot and may be revised from time to time at CM's absolute discretion.

4. Exclusions and limitations of liability to Buyers

- (a) CM shall refund the Purchase Price to the Buyer in circumstances where it deems that the lot is a counterfeit, subject to the terms of CM's Authenticity Guarantee.
- (b) Subject to Condition 4(a), neither CM nor the Seller:-
- is liable for any errors or omissions in any oral or written information provided to Bidders by CM, whether negligent or otherwise;
- (ii) gives any guarantee or warranty to Bidders and any implied warranties and conditions are excluded (save in so far as such obligations can not be excluded by English law), other than the express warranties given by the Seller to the Buyer (for which the Seller is solely responsible) under the Conditions of Business for Sellers;

- (iii) accepts responsibility to Bidders for acts or omissions (whether negligent or otherwise) by CM in connection with the conduct of auctions or for any matter relating to the sale of any lot.
- (c) Without prejudice to Condition 4(b), any claim against CM and/ or the Seller by a Bidder is limited to the Purchase Price for the relevant lot. Neither CM nor the Seller shall be liable for any indirect or consequential losses.
- (d) Nothing in Condition 4 shall exclude or limit the liability of CM or the Seller for death or personal injury caused by the negligent acts or omissions of CM or the Seller.

5. Bidding at Auction

- a) CM has absolute discretion to refuse admission to the auction. Before sale, Bidders must complete a Registration Form and supply such information and references as CM requires. Bidders are personally liable for their bid and are jointly and severally liable with their principal, if bidding as agent (in which case CM's prior and express consent must be obtained).
- (b) CM advises Bidders to attend the auction, but CM will endeavour to execute absentee written bids provided that they are, in CM's opinion, received in sufficient time and in legible form.
- (c) When available, written and telephone bidding is offered as a free service at the Bidder's risk and subject to CM's other commitments; CM is therefore not liable for failure to execute such bids. Telephone bidding may be recorded.

6. Import, Export and Copyright Restrictions

CM and the Seller make no representations or warranties as to whether any lot is subject to import, export or copyright restrictions. It is the Buyer's sole responsibility to obtain any copyright clearance or any necessary import, export or other licence required by law, including licences required under the Convention on the International Trade in Endangered Species (CITES).

7. Conduct of the Auction

- a) The auctioneer has discretion to refuse bids, withdraw or re-offer lots for sale (including after the fall of the hammer) if (s)he believes that there may be an error or dispute, and may also take such other action as (s)he reasonably deems necessary.
- (b) The auctioneer will commence and advance the bidding in such increments as (s)he considers appropriate and is entitled to place bids on the Seller's behalf up to the Reserve Price for the lot, where applicable.
- (c) Subject to Condition 7(a), the contract between the Buyer and the Seller is concluded on the striking of the auctioneer's hammer.
- (d) Any post-auction sale of lots shall incorporate these Conditions of Business.

8. Payment and Collection

- (a) Unless otherwise agreed in advance, payment of the Purchase Price is due in pounds sterling immediately after the auction (the "Payment Date").
- (b) Title in a lot will not pass to the Buyer until CM has received the Purchase Price in cleared funds. CM will generally not release a lot to a Buyer before payment. Earlier release shall not affect passing of title or the Buyer's obligation to pay the Purchase Price, as above.
- (c) The refusal of any licence or permit required by law, as outlined in Condition 6, shall not affect the Buyer's obligation to pay for the lot, as per Condition 8(a).
- (d) The buyer must arrange collection of lots within 10 working days of the auction. Purchased lots are at the Buyer's risk from the earlier of (i) collection or (ii) 10 working days after the auction. Until risk passes, CM will compensate the Buyer for any loss or damage to the lot up to a maximum of the Purchase Price actually paid by the Buyer. CM's assumption of risk is subjected to the exclusions detailed in Condition 5(d) of the Conditions of Business Sellers.

(e) All packing and handling of lots is at the Buyer's risk. CM will not be liable for any acts or omissions of third party packers or shippers.

9. Remedies for non-payment

Without prejudice to any rights that the Seller may have, if the Buyer without prior agreement fails to make payment for the lot within 5 working days of the auction, CM may in its sole discretion exercise 1 or more of the following remedies:-

- (a) store the lot at its premises or elsewhere at the Buyer's sole risk and expense;
- (b) Cancel the sale of the lot:
- Set off any amounts owed to the Buyer by CM against any amounts owed to CM by the Buyer for the lot;
- (d) Reject future bids from the Buyer;
- (e) Charge interest at 4% per annum above HSBC Bank Plc base Rate from the Payment Date to the date that the Purchase Price is received in cleared funds;
- (f) Re-sell the lot by auction or privately, with estimates and reserves at CM's discretion, in which case the Buyer will be liable for any shortfall between the original Purchase Price and the amount achieved on re-sale, including all costs incurred in such re-sale;
- (g) Exercise a lien over any Buyer's Property in CM's possession, applying the sale proceeds to any amounts owed by the Buyer to CM. CM shall give the Buyer 14 days written notice before exercising such lien;
- (h) Commence legal proceedings to recover the Purchase Price for the lot, plus interest and legal costs;
- Disclose the Buyer's details to the Seller to enable the Seller to commence legal proceedings.

10. Failure to collect purchases

- (a) If the Buyer pays the Purchase Price but does not collect the lot within 20 working days of the auction, the lot will be stored at the buyer's expense and risk at CM's premises or in independent storage.
- (b) If a lot is paid for but uncollected within 6 months of the auction, following 60 days written notice to the buyer, CM will re-sell the lot by auction or privately, with estimates and reserves at CM's discretion. The sale proceeds, less all CM's costs, will be forfeited unless collected by the Buyer within 2 years of the original auction.

11. Data Protection

- (a) CM will use information supplied by bidders or otherwise obtained lawfully by CM for the provision of auction related services, client administration, marketing and as otherwise required by law.
- (b) By agreeing to these Conditions of Business, the Bidder agrees to the processing of their personal information and to the disclosure of such information to third parties worldwide for the purpose outlined in Condition 11(a) and to Sellers as per Condition 9(i).

12. Miscellaneous

- (a) All images of lots, catalogue descriptions and all other materials produced by CM are the copyright of CM.
- (b) These Conditions of Business are not assignable by any Buyer without CM's prior consent, but are binding on Bidders' successors, assignees and representatives.
- (c) The materials listed in Condition 1(a) set out the entire agreement between the parties.
- (d) If any part of these Conditions of Business be held unenforceable, the remaining parts shall remain in full force and effect.
- (e) These Conditions of Business shall be interpreted in accordance with English Law, under the exclusive jurisdiction of the English Courts, in favour of CM.

Charles Miller Ltd's Authenticity Guarantee

If Charles Miller Ltd sells an item of Property which is later shown to be a "counterfeit", subject to the terms below Charles Miller Ltd. will rescind the sale and return the Buyer the total amount paid by the Buyer to Charles Miller Ltd. for that Property, up to a maximum of the Purchase Price.

The guarantee lasts for one (1) year* after the date of the relevant auction, is for the benefit of the Buyer only and is non-transferable.

"Counterfeit" means an item of Property that in Charles Miller Ltd.'s reasonable opinion is an imitation created with the intent to deceive over the authorship, origin, date, age, period, culture or source, where the correct description of such matters is not included in the catalogue description for the Property.

Property shall not be considered Counterfeit solely because of any damage and/or restoration and/or modification work (including, but not limited to, recolouring, tooling or repainting).

Please note that this guarantee does not apply if either:-

- the catalogue description was in accordance with the generally accepted opinions of scholars and experts at the date of the sale, or the catalogue description indicated that there was a conflict of such opinions; or
- (ii) the only method of establishing at the date of the sale that the item was a counterfeit would have been by means of processes not then generally available or accepted, unreasonably expensive or impractical; or likely to have caused damage to or loss in value to the Property (in Charles Miller Ltd.'s reasonable opinion); or

(iii) there has been no material loss in value of the Property from its value had it accorded with its catalogue description.


To claim under this guarantee the Buyer must:-

- (i) notify Charles Miller Ltd. in writing within one (1) month of receiving any information that causes the Buyer to question the authenticity or attribution of the Property, specifying the lot number, date of the auction at which it was purchased and the reasons why it is believed to be Counterfeit; and
- (ii) return the Property to Charles Miller Ltd. in the same condition as at the date of sale and be able to transfer good title in the Property, free from any third party claims arising after the date of the sale.

ARTIST'S RESALE RIGHT ("DROIT DE SUITE") δ

If a lot is affected by this right it will be identified with the symbol δ next to the lot number. The buyer agrees to pay to Charles Miller an amount equal to the resale royalty and we will pay such amount to the artist's collecting agent. Resale royalty applies where the hammer Price is 1,000 Euro or more and the amount cannot be more than 12,500 Euro per lot. The amount is calculated as follows:

invoices will, as usual, be issued in Pounds Sterling. For the purposes of calculating the resale royalty the Pounds Sterling/Euro rate of exchange will be the European Central Bank reference rate on the day of the sale. Since 1st January 2012 Droit de Suite extends to the estates of artists deceased for up to 70 years.
